Question during Pre-Bid Conference	“On the Detailed Breakdown, since this is a 12-hour duty, SSS WISP should also be included which is missing in your breakdown?”	SSS Provident is only mandatory for employees who are earning basic pay of Php 20,000.00. Payment of SSS Provident fund is voluntary for those earning below Php 20,000.00. Therefore, payment of SSS Provident is under discretion of the bidder.
