**ENJOINING NATIONAL GOVERNMENT AGENCIES, LOCAL GOVERNMENT UNITS, STATE UNIVERSITIES AND COLLEGES, AND GOVERNMENT-OWNED AND CONTROLLED CORPORATIONS TO ADOPT THE NATIONAL STATISTICAL COORDINATION BOARD (NSCB) RESOLUTION NO. 11, SERIES OF 2008, ENTITLED "ENJOINING MAJOR STATISTICAL AGENCIES AND OTHER DATA PRODUCERS TO GENERATE SEPARATE DATA FOR HIGHLY URBANIZED CITIES"**

**WHEREAS**, NSCB passed and approved Resolution No. 11, Series of 2008, " Enjoining Major Statistical Agencies and Other Data Producers to Generate Separate Data for Highly Urbanized Cities;

**WHEREAS**, the said resolution stated that the need to generate statistics for highly urbanized cities (HUCs) was raised by a number of local government units of both HUCs and the mother provinces of HUCs, as well as regional planning bodies, pointing out that HUCs are separate geopolitical units and are independent of their mother provinces, and therefore need separate data to be able to measure and monitor their economic progress and social change;

**WHEREAS**, Davao City is classified as Highly Urbanized City based on Republic Act No. 7160 known as Local Government Code of the Philippine, thus a need to separate its data from Davao del Sur;

**WHEREAS**, the Regional Land Use Committee (RLUC) XI requested the Philippine Statistics Authority XI enjoining all government agencies, local government units to discontinue referring Davao City as part of Davao del Sur in all data reporting processes, and communication.

**WHEREAS**, this Committee finds merit the request of RLUC XI for the disaggregation of data for Davao City from Davao del Sur for development planning and decision-making processes, and to measure and monitor their respective economic progress and social change; **now therefore, be it**

**RESOLVED, AS IT IS HEREBY RESOLVED**, that this Committee enjoin regional line agencies, local government units and government-owned and controlled corporation to adopt the NSCB Resolution No. 11, series of 2008;

**RESOLVED FURTHER**, that copies of this Resolution be forwarded to the Highly Urbanized City of Davao Region, Davao City Government and all other Local Government Units, all Government Agencies and entities in Davao Region, Regional Development Council XI, and the NEDA Central Offices for their information and appropriate action. *pl*
