4	Ms. Cenojas, Axzeen Security Agency:  Are they required to attach the Income Tax Return (ITR) and submit during the Bid Opening?	Member Talarde said that it is clearly stated in Item II of the Financial Component Checklist that it is the Audited Financial Statement stamped "received" by the BIR that is required.  Chairperson Aya-ay replied that ITR is not required during the submission of bid, but it is one of the additional requirements to be submitted by the Lowest Calculated Bidder (LCB) during Post Qualification evaluation (indicated in page 34 of the Bidding Document).  Additionally, Vice-Chairperson Agustin said that it is specified in Item 29.2 Bid Data Sheet, in which she read out the additional requirements to be submitted by the LCB.  Chairperson Aya-ay said that a supplemental bid will be issued to answer clearly the question.
5	Mr. Negro, Minsas Inc.:  Is the Audited Financial Statement (more or less 29 pages and prepared annually) to be submitted?	Member Talarde replied yes, the one which is stamped received by BIR Central Office.
6	Ms. Cenojas, Axzeen Security Agency: For the technical component, are they required to submit remittances?	Chairperson Aya-ay responded that remittances are not required during the Bid Opening, but as part of the Post Qualification evaluation.
7	Mr. Negro, Minsas Inc.:  Are they required to attach the hardcopy of the all on-going contracts as indicated in the Statement of On-going contracts?	Chairperson Aya-ay said that they do not need to attach the contracts, only the list of all ongoing contracts.
8	Ms. Cenojas, Axzeen Security Agency: Are they required to attach the Single Largest Completed Contract (SLCC)?	Chairperson Aya-ay said that they do not need to attach the contract, only statement of the SLCC.
