Highlights of Population in the Municipality of Montevista based on the 2020 Census of Population and Housing (2020 CPH)

Municipality of Montevista population was recorded at 46,558 persons

The total population of the Municipality of Montevista as of May 1, 2020 was 46,558 persons based on the 2020 Census of Population and Housing (2020 CPH). It accounted for about 6.1 percent of the Davao de Oro population in 2020.

The population of the municipality for the year 2020 is higher by 2,852 persons compared with the population of 43,706 in 2015; by 6,956 persons compared with the population of 39,602 in 2010; and by 13,333 persons compared with the population of 33,225 in 2000. (see Table 1)

The municipality population grew by 1.34 percent

The total population of Montevista increased by 1.34 percent annually, on average, during the period of 2015 to 2020. By comparison, the rate at which the municipality population grew during the period of 2010 to 2015 was higher at 1.89 percent (see Table 2)

Barangay San Jose (Poblacion) consistently has the biggest population municipalwide

The Municipality of Montevista has 20 barangays. In 2020, Barangay San Jose (Poblacion) had the biggest population with 9,076 persons residing in the barangay or contributed 19.49 percent out of the total population of the municipality, followed by Barangay New Visayas with 5,773 persons or 12.40 percent and Barangay Linoan with 4,184 persons or 8.99 percent, respectively. (see Table 3)

Barangay Banglasan had the smallest population size with 831 persons or accounted for only 1.78 percent of the municipality population, followed by Barangay New Cebulan (Sambayon) with 966 persons or 2.07 percent and Barangay Camantangan with 973 persons or 2.09 percent.

New Visayas is the fastest growing barangay

Barangay New Visayas was the fastest growing barangay in the municipality with an average annual population growth rate (PGR) of 10.04 percent during the period of 2015 to 2020. It was followed by Barangay San Vicente with a PGR of 3.85 percent, and Barangay Linoan with 3.50 percent. (see Table 4)

On the other hand, Barangay Canidkid was the slowest growing barangay with a PGR of 0.51 percent, followed by Barangay Dauman with PGR of 0.84 percent, and Barangay Bankerohan Sur with PGR of 1.06 percent.

Additionally, 11 barangays of Montevista posted a negative PGR, of which Barangay Banglasan has the highest negative PGR of 3.80 percent, while Barangay San Jose (Poblacion) has the lowest negative PGR of 0.01 percent.

TECHNICAL NOTES

- The 2020 CPH was undertaken by the Philippine Statistics Authority in September 2020 pursuant to Republic Act No. 10625, also known as the Philippine Statistical Act of 2013 and B.P. Blg. 72 further accorded the PSA the authority to conduct population censuses every ten (10) years beginning in 1980.
- Information on the count of the population were collected with 12:01 a.m. of May 1, 2020 as the census reference time and date.
- The 2020 CPH is the country's 15th Census of Population and 7th Census of Housing since 1903.
- Doubling time is the amount of time it takes for a given quantity to double in size or value at a constant growth rate. We can find the doubling time for a population undergoing exponential growth by using the **Rule of 70**. To compute for doubling time, we divide 70 by the growth rate (r).
- His Excellency President Rodrigo R. Duterte declared as official for all purposes the population counts by province, city/municipality, and barangay, based on the 2020 CPH under Proclamation No. 1179 dated 06 July 2021. The population counts were based on census questionnaires accomplished by about 90,000 enumerators deployed during the nationwide census taking.
- The successful completion of the census-taking was made possible with the support of the local and national officials, government agencies, local government units, media, private agencies, and non-government organizations.
