Highlights of Population in the Municipality of Pantukan based on the 2020 Census of Population and Housing (2020 CPH)

Municipality of Pantukan population was recorded at 90,786 persons

The total population of the Municipality of Pantukan as of May 1, 2020 was 90,786 persons based on the 2020 Census of Population and Housing (2020 CPH). It accounted for about 11.8 percent of the Davao de Oro population in 2020.

The population of the municipality for the year 2020 is higher by 4,887 persons compared with the population of 85,899 in 2015; by 11,719 persons compared with the population of 79,067 in 2010; and by 28,985 persons compared with the population of 61,801 in 2000. (see *Table 1*)

The municipality population grew by 1.17 percent

The total population of Pantukan increased by 1.17 percent annually, on average, during the period of 2015 to 2020. By comparison, the rate at which the municipality population grew during the period of 2010 to 2015 was higher at 1.59 percent (see *Table 2*)

Barangay Kingking (Poblacion) consistently has the biggest population municipalwide

The Municipality of Pantukan has 13 barangays. In 2020, Barangay Kingking (Poblacion) had the biggest population with 29,317 persons residing in the barangay or contributed 32.29 percent out of the total population of the municipality, followed by Barangay Napnapan with 12,529 persons or 13.80 percent and Barangay Magnaga with 10,766 persons or 11.86 percent, respectively. (see Table 3)

Barangay Las Arenas had the smallest population size with 980 persons or accounted for only 1.08 percent of the municipality population, followed by Barangay Araibo with 2,531 persons or 2.79 percent and Barangay P. Fuentes with 3,908 persons or 4.30 percent.

Bongbong is the fastest growing barangay

Barangay Bongbong was the fastest growing barangay in the municipality with an average annual population growth rate (PGR) of 4.83 percent during the period of 2015 to 2020. It was followed by Barangay Matiao with a PGR of 4.09 percent, and Barangay Tambongon with 3.84 percent. (see Table 4)

On the other hand, Barangay P. Fuentes was the slowest growing barangay with a PGR of 0.70 percent, followed by Barangay Kingking (Poblacion) with PGR of 1.76 percent, and Barangay Magnaga with PGR of 2.08 percent.

Additionally, 6 barangays of Pantukan posted a negative PGR, of which Barangay Napnapan has the highest negative PGR of 1.41 percent, while Barangay Tag-Ugpo has the lowest negative PGR of 0.05 percent.

TECHNICAL NOTES

- The 2020 CPH was undertaken by the Philippine Statistics Authority in September 2020 pursuant to Republic Act No. 10625, also known as the Philippine Statistical Act of 2013 and B.P. Blg. 72 further accorded the PSA the authority to conduct population censuses every ten (10) years beginning in 1980.
- Information on the count of the population were collected with 12:01 a.m. of May 1, 2020 as the census reference time and date.
- The 2020 CPH is the country's 15th Census of Population and 7th Census of Housing since 1903.
- Doubling **time** is the amount of time it takes for a given quantity to double in size or value at a constant growth rate. We can find the doubling time for a population undergoing exponential growth by using the **Rule of 70**. To compute for doubling time, we divide 70 by the growth rate (r).
- His Excellency President Rodrigo R. Duterte declared as official for all purposes the population counts by province, city/municipality, and barangay, based on the 2020 CPH under Proclamation No. 1179 dated 06 July 2021. The population counts were based on census questionnaires accomplished by about 90,000 enumerators deployed during the nationwide census taking.
- The successful completion of the census-taking was made possible with the support of the local and national officials, government agencies, local government units, media, private agencies, and non-government organizations.
