**RSC XI Resolution No. 04  
Series of 2021**

**ENJOINING LOCAL GOVERNMENT UNITS TO ASSIST THE PSA IN THE  
ESTABLISHMENT OF REGISTRATION CENTERS FOR THE IMPLEMENTATION OF  
PHILIPPINE IDENTIFICATION SYSTEM**

**WHEREAS**, on 06 August 2018, Republic Act No. 11055 entitled "An Act Establishing the Philippine Identification System (PhilSys)" was approved and signed into law;

**WHEREAS**, RA 11055 provides that the Philippine Statistics Authority (PSA) shall be the primary implementing agency to carry out the provisions of this Act which includes overall planning, management, and administration of the PhilSys;

**WHEREAS**, the PhilSys shall establish a single national identification system for all citizens and resident aliens of the Republic of the Philippines;

**WHEREAS**, this Committee issued Resolution No. 10 series of 2019, enjoining the support of regional and local government agencies, Government-Owned and Controlled Corporations (GOCCs), academe, media, and the private sector in the successful implementation of the PhilSys in the Region;

**WHEREAS**, the PSA XI reported to this Committee that as of 08 March 2021, the total number of active registration centers are only 26 as opposed to its 94 proposed registration centers in the region for year 2021;

**WHEREAS**, this Committee deems it necessary to reiterate the call for support needed from the LGUs in the Region of this undertaking;

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY ESOLVED**, that this Committee enjoins the LGUs to assist the PSA in the establishment of Registration Centers for the implementation of the PhilSys in their respective jurisdiction;

**RESOLVED FURTHER**, that a copy of this Resolution be furnished to concerned agencies and the PSA Central Office for information and appropriate action;
