RSC XI Resolution No. 08 Series of 2019

ENJOINING DAVAO REGION'S PROVINCES AND ITS HIGHLY-URBANIZED CITY TO ESTABLISH THEIR RESPECTIVE PROVINCIAL/CITY STATISTICS COMMITTEES

WHEREAS, the Philippine Statistics Authority (PSA) is mandated through RA 10625, also known as the "Philippine Statistical Act of 2013," to coordinate with local government units (LGUs) on the promotion and adoption of statistical standards involving techniques, methodologies, concepts, definitions and classifications and on the avoidance of duplication in the collection of statistical information:

WHEREAS, PSA Board Resolution No. 05 s. 2015 established the Regional Statistics Committees (RSCs) to provide direction and guidance on statistical matters and institute coordinative mechanisms at the regional and local levels;

WHEREAS, there is a need to establish Provincial Statistics Committees (P/CSCs) for a well-coordinated statistical system at the sub-regional/provincial and city levels as coordinator in improving the statistical system that is responsive to development planning and monitoring;

WHEREAS, the P/CSCs will replicate the functions of the Regional Statistics Committee at the provincial/city levels and serve as clearing house for all statistics generated in the province and cities;

WHEREAS, this Committee recognizes the need for the LGUs to exercise autonomy in discharging their functions and responsibilities and in making decisions to address statistical issues at the provincial level;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that this Committee enjoin Davao Region's five provinces and the City of Davao to establish their respective Provincial/City Statistics Committees;

RESOLVED FURTHER, that this Committee seek the support of the Regional Development Council (RDC) XI on enjoining the Region's provinces and its highly-urbanized city to establish their respective Provincial/City Statistics Committees.

RESOLVED FURTHER, that this Resolution be forwarded to the Region's Provincial Development Councils and to Davao City Development Council for their appropriate action, and to the RDC XI for its support.
