**RSC XI Resolution No. 10  
Series of 2019**

**ENJOINING REGIONAL LINE AGENCIES, LOCAL GOVERNMENT UNITS, GOVERNMENT-OWNED AND CONTROLLED CORPORATION, ACADEME, MEDIA AND PRIVATE SECTOR TO SUPPORT THE PHILIPPINE IDENTIFICATION SYSTEM (PhilSys)**

**WHEREAS**, on 06 August 2018, Republic Act No. 11055 entitled "An Act Establishing the Philippine Identification System (PhilSys)" was approved and signed into law;

**WHEREAS**, RA 11055 provides that the Philippine Statistics Authority shall be the primary implementing agency to carry out the provisions of this Act which includes overall planning, management, and administration of the PhilSys;

**WHEREAS**, the PhilSys shall establish a single national identification system for all citizens and resident aliens of the Republic of the Philippines;

**WHEREAS**, the PhilSys primarily aims to provide a valid proof of identity for all citizens and resident aliens as a means of simplifying public and private transactions without having the need to present other forms of identification. Furthermore, the PhilSys shall be a social and economic platform through which all transactions including public and private services can be availed of and shall serve as the link in the promotion of seamless delivery of service, enhancing administrative governance, reducing corruption, averting fraudulent transactions and misinterpretations, strengthening financial inclusion, and promoting ease of doing business;

**WHEREAS**, the support of regional and local government agencies, Government-Owned and Controlled Corporations (GOCCs), academe, media, and the private sector through information dissemination on the implementation of the PhilSys is deemed necessary for the success of the undertaking;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that RSC XI enjoins RLAs, LGUs, Academe, Media, and Private sector to support the PhilSys;

**RESOLVED FURTHER**, that concerned entities be furnished a copy of this Resolution for their information and appropriate action; *re*
