**CONSTITUTING THE MEMBERSHIP OF THE**  
**REGIONAL STATISTICS COMMITTEE OF DAVAO REGION**

**WHEREAS**, Republic Act No. 10625, otherwise known as the “Philippine Statistical Act of 2013” mandated the creation of the Philippine Statistics Authority (PSA) Board as the highest policy-making body on statistical matters;

**WHEREAS**, one of the functions of the PSA Board is to prescribe appropriate framework for the improvement of statistical coordination and establish mechanisms for statistical coordination at the regional and local levels;

**WHEREAS**, the PSA Board approved the establishment of Regional Statistics Committees (RSC) through Resolution No. 05, series of 2015 dated March 20, 2015 to provide direction and guidance to regional/local statistical development activities;

**WHEREAS**, based on Resolution No. 5-2015, the RSC XI shall be chaired by the Regional Director of the National Economic and Development Authority (NEDA) XI, and vice-chaired by the Regional Director of PSA XI; while the PSA Regional Statistical Services Office (RSSO) XI shall provide the technical secretariat services and administrative support thereto;

**WHEREAS**, the RSC XI shall comprise of the following members:

## ANNEX B POWERS AND FUNCTIONS OF THE RSC XI

The RSC XI shall carry out the following powers and functions:

1. Oversee the implementation in the region of policy decisions made by the PSA Board and the adoption of prescribed statistical standard methodologies and classification system;
2. Formulate statistical policies designed to resolve statistical issues in the region and recommend workable schemes towards the improvement of statistics in Davao Region;
3. Institute measures to strengthen the statistical capability of the statistical system in the region including the personnel thereof;
4. Elevate to the PSA Board, any statistical matters which cannot be resolved in the region;
5. Create interagency statistical working groups in the region, as the need arises, that could attend to technical issues and problems and supervise the activities of these working groups;
6. Meet at least once a quarter at such date, time and place it may decide; and
7. Submit on time reports periodically to PSA Central Office.
