**ENDORISING THE REGIONAL DEVELOPMENT COUNCIL XI ADVISORY COMMITTEE  
RESOLUTION NO. 9, SERIES OF 2019 TO THE PSA BOARD  
FOR INFORMATION AND APPROPRIATE ACTION**

**WHEREAS**, the Regional Development Council (RDC) is the highest policy-making body in the region and serves as the counterpart of the NEDA Board at the subnational level, which primary task is to coordinate development planning and policy making in the region;

**WHEREAS**, RDC XI recognizes the need to generate annual and geographically-disaggregated poverty statistics to make better decisions in terms of planning and project implementation;

**WHEREAS**, the official estimates on poverty incidence is taken mainly from the Family Income and Expenditure Survey, a nationwide survey of households undertaken every three years by the Philippine Statistics Authority (PSA).

**WHEREAS**, during its meeting on October 25, 2019, the RDC XI Advisory Committee (AdCom) issued Resolution No. 9, series of 2019, "Enjoining the Philippine Statistics Authority (PSA) to Develop a Tool to Disaggregate Poverty Incidence Data";

**WHEREAS**, the subject Resolution states that Atty. Matunog, the RDC XI - Macroeconomy and Finance Committee Chairperson, commits that ICT-Davao, a 20-member organization from the Information and Communication Technology (ICT) sector, can provide a platform in the development of a database to reinforce the government's ability to generate regular and geographically disaggregated statistics on poverty at the city, municipality, and barangay levels;

**WHEREAS**, during the RSC XI meeting on December 13, 2019, the proposal enjoining the Philippine Statistics Authority (PSA) to develop a tool to disaggregate poverty incidence data was discussed as part of the agenda;

**WHEREAS**, RSC XI agreed that the proposal be forwarded to the PSA Board for its appropriate action.;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that this Committee endorse to the PSA Board the RDC XI AdCom Resolution No. 9, series of 2019, for appropriate action.

**RESOLVED FURTHER**, that a copy of this Resolution be furnished to the RDC XI and PSA Board for information and appropriate action;
