## RSC XI Resolution No. 02 Series of 2017

RECOMMENDING THAT GOVERNMENT AGENCIES, LOCAL GOVERNMENT UNITS AND GOVERNMENT-OWNED AND CONTROLLED CORPORATIONS IN REGION XI DELEGATE A FOCAL PERSON ON SUSTAINABLE DEVELOPMENT GOALS

WHEREAS, the Sustainable Development Goals (SDGs), adopted by world leaders in September 2015 at the UN Sustainable Development Summit, shall build on the success of the Millennium Development Goals and universally apply to all countries to end all forms of poverty, fight inequalities and tackle climate change, while ensuring that no one is left behind:

WHEREAS, the Philippines, together with other UN member states shall develop indicators at the national and sub-national levels to complement the global SDG indicators, taking into account national circumstances;

WHEREAS, there is high demand for relevant, timely and disaggregated statistics for the monitoring of numerous SDG indicators and targets;

WHEREAS, the Philippine Statistics Authority (PSA) Board, as the country's central statistical authority passed Resolution No. 04, s. 2016 enjoining government agencies at the national and subnational/local levels to provide necessary data support to monitor the country's performance on the SDGs;

WHEREAS, this Committee discussed issues and challenges on the generation of SDG data and deemed that the delegation of SDG focal persons in government agencies, LGUs and government-owned and controlled corporations shall facilitate the coordination on SDG data generation;

WHEREAS, the SDG focal persons shall compile and regularly provide timely and accurate data to PSA as repository of SDG indicators, answer inquiries related to SDG, monitor and coordinate with other agencies for improvements in SDG indicators;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that this Committee recommend that government agencies, local government units and government-owned and controlled corporations in Davao Region delegate a focal person on Sustainable Development Goals to coordinate SDG data generation activities.

**RESOLVED FURTHER**, that copies of this Resolution be forwarded to NEDA and PSA Central Offices and government agencies, LGUs and GOCCs in Davao Region for their information/appropriate action.
