### RSC XI Resolution No. 04 Series of 2016

#### **REQUESTING THE REGIONAL DEVELOPMENT COUNCIL XI TO ENDORSE THE CONDUCT OF BARANGAY AGRICULTURAL PROFILING SURVEY IN DAVAO REGION AND TO URGE LOCAL GOVERNMENT UNITS' SUPPORT THEREOF**

**WHEREAS**, the Philippine Statistics Authority (PSA) is mandated by law through Section 6 of Republic Act No. 10625 to collaborate with departments of the national government including GOCCs and their subsidiaries in the collection, compilation, maintenance and publication of statistical information, including special statistical data derived from the activities of those departments, corporations and their subsidiaries;

**WHEREAS**, the PSA is likewise authorized to prepare and conduct periodic censuses on population, housing, agriculture, fisheries, business, industry and other sectors of the economy;

**WHEREAS**, the basic and current data on agriculture are usually generated through national censuses and surveys and are disaggregated up to provincial level only, thus inadequate to meet the needs of planners and policy makers of local government units, particularly the cities/municipalities and barangays;

**WHEREAS**, in response to the need for comprehensive, timely, and reliable data with municipal and barangay levels of disaggregation, the PSA, with funding assistance from the Department of Agriculture, has conceptualized the Barangay Agricultural Profiling Survey (BAPS);

**WHEREAS**, the BAPS is designed to collect information on the basic structure of agriculture and fishery at the barangay level, which can be effective inputs to the government in the identification, design, and implementation of appropriate development programs;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to request the Regional Development Council (RDC) XI to endorse the conduct of BAPS in Davao Region;

**RESOLVED FURTHER**, to request the RDC XI to urge the local government units to actively participate and support the BAPS;

**RESOLVED FINALLY**, that a copy of this Resolution be forwarded to the RDC XI for its consideration.
