WHEREAS, the 27th National Statistics Month (NSM), with the theme: '*Sustainable Development: Making Statistics Count*' was celebrated nationwide in October 2016 pursuant to Presidential Proclamation No. 647, s. 1990 "Declaring the Month of October of Every Year as the National Statistics Month";

WHEREAS, the NSM celebration aimed to: 1) promote, enhance, and instill nationwide awareness and appreciation of the importance and value of statistics to the different sectors of society; and (b) elicit the cooperation and support of the general public in upgrading the quality and standards of statistics;


