**RSC XI Resolution No. 08**  
**Series of 2016**

**REQUESTING THE RDC XI TO ENDORSE THE PHILIPPINE STATISTICS AUTHORITY AS LEAD AGENCY IN THE ADMINISTRATION OF DATA ON THE REGISTRY SYSTEM ON BASIC SECTORS IN AGRICULTURE**

**WHEREAS**, the Registry System on Basic Sectors in Agriculture (RSBSA) is an electronic compilation of basic information on the target beneficiaries of agriculture-related programs and services, such as farmers, farm laborers and fishermen;

**WHEREAS**, the RSBSA provides manageable access to baseline agricultural information and addresses the need for a comprehensive and systematic information system on agriculture that caters to the information needs of economic development planners, policymakers and project implementers;

**WHEREAS**, the Department of Budget and Management (DBM) is the lead government agency for the implementation of the entire RSBSA undertaking, with the following members: Department of the Interior and Local Government, Department of Agriculture, Department of Agrarian Reform, and the Philippine Statistics Authority;

**WHEREAS**, the DBM-Office of the Chief Information Officer is co-terminus with every change of the administration and as such, there is a need for a permanent lead agency to ensure that information access to programs for farmers, farm laborers and fishermen are sustained;

**WHEREAS**, the Philippine Statistics Authority (PSA) is mandated by Republic Act No. 10625 to collaborate with departments of the national government including GOCCs and their subsidiaries in the collection, compilation, maintenance and publication of statistical information, including special statistical data derived from the activities of those departments, corporations and their subsidiaries;

**WHEREAS**, this Committee deems that PSA is the lead agency to administer the RSBSA in consideration of its mandate and competence to organize and operationalize an Inter-Agency Committee on Agriculture, which can address the need for a platform for governance structure for the organization, maintenance and updating of the RSBSA;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that this Committee request the Regional Development Council XI to endorse the Philippine Statistics Authority as the lead agency in the administration of data of the Registry System on Basic Sectors in Agriculture;

**RESOLVED FINALLY**, that this Resolution be forwarded to the Regional Development Council XI for its consideration.






