## Highlights of the Philippine Identification System (PhilSys) Electronic Philippine Identification (ePhilID), National ID, Digital National ID and other services in the province of Davao Occidental for the First Semester of year 2024

### PSA Davao Occidental reached a 100 thousand mark of issued ePhilIDs in the province

As of June 2024, PhilSys Davao Occidental successfully issued a total of 115,820 ePhilIDs which is 42.05% of the total 275,390 registered individuals in the province.

In the First Semester of 2024, PSA Davao Occidental issued 1,452 ePhilIDs, 1,097 from the First Quarter (January-March 2024) and 355 in the Second Quarter of the year (April-June 2024) (Table 1).

### A total of 20 National ID replacement successfully claimed by registrants

Last July 2023, PSA Davao Occidental launched the replacement of National ID with defective front-facing photograph. Registrants with peeled-off front-facing photograph in their National ID can now request a replacement.

As of June 2024, a total 39 request has been filed; 26 of the requests were already printed and sent back to PSA Davao Occidental; only one (1) request that is for investigation. Out of the 46 National IDs, 23 were successfully delivered or claimed. (Table 2)

National ID eVerify is an online platform that streamline the onboarding process (regulatory and technical) of Relying Parties (RP) to the National ID Authentication Services.

The National ID eVerify redefines identity verification through faster, seamless, and more secure transactions and onboarding.

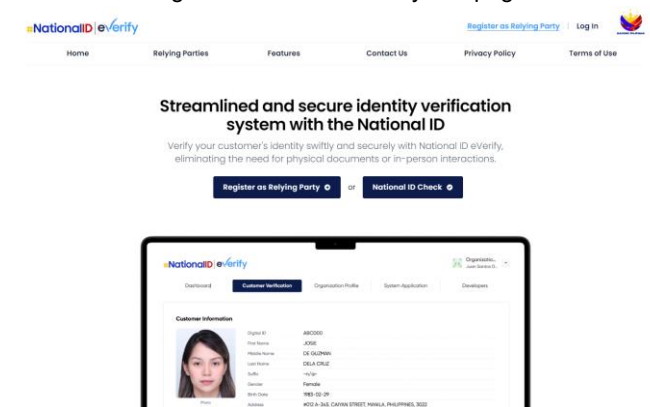
### Identity Theft Prevention

## TECHNICAL NOTES

Step 1 Pre-registration	refers to the collection of a registrant's demographic data such as name, date of birth, address, marital status, etc.
National ID Registration	refers to the capturing of a registrant's biometric information such as iris scans, fingerprints and front-facing photograph
ePhilID	refers to an e-copy or alternative version of the National ID, this copy can be printed to a paper by PhilSys
Digital National ID	refers to a version of the National ID that can be access by any registrant in this website: <a href="https://national-id.gov.ph">https://national-id.gov.ph</a>
National ID eVerify	refers to a online platform that will provide National ID Authentication Services

Republic Act No. 11055, or the Philippine Identification System Act, signed into law by President Rodrigo Roa Duterte on August 06, 2018, aims to establish a single national identification system for all citizens and resident aliens of the Republic of the Philippines. The valid proof of identity provided by the PhilSys shall be a means of simplifying public and private transactions, and shall be a social and economic platform that promotes seamless social service delivery and strengthens financial inclusion for both public and private services. As a foundational digital ID System, the PhilSys will transform how services are delivered in the Philippines, and accelerate our transition into a digital economy, including to enable presence-less, paperless, and cashless transactions.
